CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that KINGMAN COLONY IRRIGATION COMPANY, of NYSSA, OREGON, has a right to the use of the waters of SNAKE RIVER, tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 1885.34 ACRES AND DOMESTIC.

The right has been perfected under Permit 1150. The date of priority is FEBRUARY 17, 1912. The right is limited to not more than 22.35 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

#1 - NW1/4 SW1/4, SECTION 31, T 20 S, R 47 E, WM; #2 - SE1/4 SE1/4, SECTION 12, #3 - NE1/4 SE1/4, SECTION 14, #4 - NE1/4 SE1/4 SECTION 22, T21S, R46E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
