CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ARTHUR L. MCGREER, of ANTELOPE, OREGON 97001, has a right to the use of the waters of JOHN DAY RIVER, TRIBUTARY OF COLUMBIA RIVER, for the purpose of IRRIGATING 39.7 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1907.

The right is limited to not more than ONE-FORTIETH CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30, FURTHER LIMITED TO ONE ACRE FOOT PER ACRE PER CALENDAR MONTH; TOTAL OF FIVE ACRE FEET PER ACRE FOR SEASON, MEASURED AT POINT OF DIVERSION.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 9, T 8 S, R 19 E, WM; 4440 FEET SOUTH & 3440 FEET WEST FROM THE NE CORNER, SECTION 9.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by certificate 45229, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered September 28, 1987, approving transfer application 5970.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
