CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that JOHN DAY, of P.O. BOX 488, MEDFORD, OREGON 97501, has a right to the use of the waters of ROGUE RIVER, TRIBUTARY OF PACIFIC OCEAN, for the purpose of IRRIGATING 205.85 ACRES.

The right has been perfected under Permit 23796. The date of priority is JULY 28, 1955. The right is limited to not more than 2.57 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW1/4 NE1/4, SECTION 18, T 36 S, R 2 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
