CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that CLYDE HOLIDAY, of ROUTE 2, BOX 90, JOHN DAY, OREGON 97845, has a right to the use of the waters of JOHN DAY RIVER, TRIBUTARY OF COLUMBIA RIVER, for the purpose of PRIMARY IRRIGATION OF 11.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 56.0 ACRES.

The right has been perfected under Permit 8655. The date of priority is AUGUST 24, 1928. The right is limited to not more than 0.84 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; NW1/4 SW1/4, SECTION 13, TOWNSHIP 13 SOUTH, RANGE 32 EAST, WM; 2300 FEET NORTH & 700 FEET EAST FROM SW CORNER SECTION 3, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE1/4 SW1/4, SECTION 14, TOWNSHIP 13 SOUTH, RANGE 32 EAST, WM; 2040 FEET NORTH & 2020 FEET EAST FROM SW CORNER SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
