CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that GEORGE D. MCDANIEL, of P.O. BOX 1012, LAGRANDE, OREGON 97850, has a right to the use of the waters of WALLOWA RIVER, A TRIBUTARY OF GRANDE RONDE RIVER, for the purpose of IRRIGATING 57.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for WALLOWA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at page 148. The date of priority is 1890.

The right is limited to not more than 1.5 ACRE-FEET PER ACRE DURING ANY PERIOD OF 30 DAYS PRIOR TO JULY 31ST OF EACH YEAR, AND THEREAFTER NOT TO EXCEED 1.0 ACRE-FOOT PER ACRE DURING THE ENTIRE REMAINDER OF THE IRRIGATION SEASON, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION FOR SLOUGH DITCH.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 11, T 1 S, R 43 E, WM; CROSS COUNTRY DITCH - 1410 FEET NORTH & 2970 FEET EAST FROM SW CORNER SECTION 11.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

6.0 ACRES SW1/4 NW1/4
15.0 ACRES NE1/4 SW1/4
36.0 ACRES NW1/4 SW1/4
SECTION 11
TOWNSHIP 1 SOUTH, RANGE 43 EAST, W.M.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered March 16, 1977, and together with certificate 45009, supersedes certificate 2952, STATE RECORD OF WATER RIGHT CERTIFICATES.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
