

## CERTIFICATE OF WATER RIGHT



THIS IS TO CERTIFY, that WILLIAM J. FERGUSON, of 147 LIBERTY STREET NE, SALEM, OREGON 97301, has a right to the use of the waters of RICKREALL CREEK, TRIBUTARY OF WILLAMETTE RIVER, for the purpose of IRRIGATING 7.7 ACRES.

The right has been perfected under Permit 20640. The date of priority is JUNE 20, 1962. The right is limited to not more than 0.094 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW1/4 SW1/4, AS PROJECTED WITHIN LOVELADY DLC 63, SECTION 35, T 7 S, R 5 W, WM; 390 FEET SOUTH & 420 FEET EAST FROM THE NE CORNER HARRIS DLC 66.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

4.1 ACRES SE1/4 NE1/4 AS PROJECTED WITHIN DLC 63

1.0 ACRE NE1/4 SE1/4 AS PROJECTED WITHIN DLC 66 SECTION 34

2.6 ACRES SW1/4 NW1/4
AS PROJECTED WITHIN DLC 63
SECTION 35
TOWNSHIP 7 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by certificate 34287, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered FEBRUARY 18, 1988, approving transfer application 5999.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
