CERTIFICATE OF WATER RIGHT

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1. The date of priority is 1875.

The right is limited to not more than 0.583 CUBIC FOOT PER SECOND.
