CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that JOHN COMPTON CO., of P.O. BOX 768, MCMINNVILLE, OREGON 97128, has a right to the use of the waters of SQUAW CREEK, TRIBUTARY OF DESCHUTES RIVER, for the purpose of IRRIGATING 50.0 ACRES.

The right has been perfected under Permit 18203. The date of priority is MARCH 5, 1948. The right is limited to not more than $0.45~\mathrm{CUBIC}$ FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW1/4 NW1/4, SW1/4 SW1/4, SECTION 35, T 14 S, R 10 E, WM; #1 - 490 FEET NORTH & 620 FEET EAST FROM W1/4 CORNER SECTION 35; #2 - 1120 FEET NORTH & 850 FEET EAST FROM SW CORNER SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 ACRE FEET acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered March 12, 1982 and supersedes certificate 24619, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
