CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that DONALD D. NORTON, of IMNAHA, OREGON 97842, has a right to the use of waters of ADAMS CREEK FOR TRACT NO. 1 AND IMNAHA RIVER FOR TRACT NO. 2, a tributary of SNAKE RIVER, for the purpose of IRRIGATING 37.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for WALLOWA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 11, at page 6. The date of priority is 1889.

The right is limited to not more than THREE-EIGHTIETHS of one cubic foot per second per acre of land irrigated, and not to exceed one and one-half acre feet per acre during any period of 30 days during the irrigation season.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 25; SW 1/4 SE 1/4, SECTION 26; NW 1/4 NE 1/4, SECTION 35, T 1 S, R 48 E, W.M.; ADAMS CREEK; 770 FEET NORTH AND 2050 FEET EAST, IMNAHA RIVER; 1300 FEET NORTH AND 2360 FEET WEST, 460 FEET NORTH AND 2370 FEET WEST, 940 FEET SOUTH AND 2050 FEET WEST ALL FROM NE CORNER SECTION 35.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm the remaining right and a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 28, 1977, and supersedes certificate 9322, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
