## CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ROBERT D. MURPHY, of 1424 NORTH RIVER ROAD, GOLD HILL, OREGON 97525, has a right to the use of the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 41.2 ACRES.

The right has been perfected under Permit 17846. The date of priority is JULY 16, 1947. The right is limited to not more than 0.52 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (SE 1/4 NE 1/4), SECTION 24, T 36 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season from APRIL 2 TO OCTOBER 31, of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 6 (SW 1/4 NE 1/4) 14.0 ACRES LOT 7 (SE 1/4 NE 1/4) 12.2 ACRES SW 1/4 NW 1/4 1.1 ACRES SE 1/4 NW 1/4 13.9 ACRES SECTION 24

TOWNSHIP 36 SOUTH, RANGE 4 WEST, W.M.

This certificate describes that portion of the water right confirmed by certificate 19683, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered OCTOBER 30, 1975, approving transfer application 3148, AND together with certificate 50144, supercedes certificate 19683, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
