CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

ALAN M DALTON

of RT 1 BOX 213 G CARLTON, OR 97111

has a right to the use of the waters of PANTHER CREEK, A DRAINAGEWAY AND UNNAMED POND CONSTRUCTED UNDER PERMIT R-6113, TRIBUTARY OF YAMHILL RIVER

for the purpose of IRRIGATION AND FISH CULTURE.

The right to the use of these waters has been perfected under Permit 37771. The date of priority is OCTOBER 11, 1974. The right is limited to not more than 0.07 CUBIC FOOT PER SECOND; BEING 0.06 CFS FOR IRRIGATION FROM PANTHER CREEK & 0.01 CFS FROM UNNAMED DRAINAGEWAY AND POND FOR FISH CULTURE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM DRAINAGEWAY TO BE MADE UP BY DIVERSION * or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

(point 1) SW 1/4 NE 1/4, Section 20, T 03 S, R 05 W, WM; 1875 FEET SOUTH & 920 FEET EAST FROM THE N1/4 CORNER, SECTION 20 (point 2) SW 1/4 NE 1/4, Section 20, T 03 S, R 05 W, WM; 2200 FEET SOUTH & 980 FEET EAST FROM THE N1/4 CORNER SECTION 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
