THIS IS TO CERTIFY, that

has a right to the use of the waters of A SPRING AND AN UNNAMED
STREAM, TRIBUTARY OF APPLEGATE RIVER
for the purpose of DOMESTIC USE FOR ONE FAMILY INCLUDING
THE IRRIGATION OF NOT TO EXCEED 1/2 ACRE LAWN AND GARDEN,
AND IRRIGATION, AND SUPPLEMENTAL IRRIGATION.

The right to the use of these waters has been perfected under Permit 32691. The date of priority is JUNE 22, 1967. The right is limited to not more than 0.89 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM THE SPRING FOR DOMESTIC AND 0.88 CFS FROM THE STREAM FOR IRRIGATION

or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

NW 1/4 SE 1/4, Section 27, T 37 S, R 05 W, WM; 3100 FEET SOUTH & 3870 FEET EAST FROM NW CORNER SECTION 27
NE 1/4 SW 1/4, Section 27, T 37 S, R 05 W, WM; 2660 FEET SOUTH & 2470 FEET EAST FROM NW CORNER SECTION 27

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
