CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

MEADOWS TRUST, C/O BETH PETERSON of 10398 TAKILMA RD CAVE JUNCTION, OR 97523 has a right to the use of the waters of SCOTCH GULCH CREEK AND SOUTH FORK SCOTCH GULCH CREEK, TRIBUTARY OF EAST FORK ILLINOIS RIVER for the purpose of IRRIGATION AND DOMESTIC USE FOR THREE FAMILIES.

The right to the use of these waters has been perfected under Permit 38622. The date of priority is JUNE 3, 1974. The right is limited to not more than 0.17 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC; 0.09 CFS FOR IRRIGATION FROM SCOTCH GULCH CREEK; 0.005 CFS FOR DOMESTIC AND 0.07 CFS FOR IRRIGATION FROM SOUTH FORK SCOTCH GULCH CREEK or its equivalent in case of rotation, measured at the point of

or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

(point 1) SW 1/4 NE 1/4, Section 4, T 41 S, R 08 W, WM; 1570 FEET SOUTH & 1700 FEET WEST FROM NE CORNER, SECTION 4 (point 2) LOT 5, SW 1/4 NW 1/4, Section 3, T 41 S, R 08 W, WM; 2160 FEET SOUTH & 30 FEET EAST FROM NE CORNER, SECTION 4

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
