CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

LERROY PERKINS
of 19975 WILSON RIVER HWY TILLAMOOK, OR 97141
has a right to the use of the waters of AN UNNAMED SPRING AND WILSON RIVER, TRIBUTARY OF TILLAMOOK BAY
for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION.

The right to the use of these waters has been perfected under Permit 40317. The date of priority is MAY 21, 1975. The right is limited to not more than 0.035 CUBIC FOOT PER SECOND; BEING 0.005 CFS FROM SPRING FOR DOMESTIC USE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SPRING TO BE MADE UP BY APPROPRIATION FROM WILSON RIVER & 0.03 CFS FROM WILSON RIVER FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

- (point 1) SW 1/4 NW 1/4, Section 10, T 01 S, R 08 W, WM; 1810 FEET SOUTH & 120 FEET EAST FROM NE CORNER OF SECTION 9
- (point 2) SW 1/4 NW 1/4, Section 10, T 01 S, R 08 W, WM; 1870 FEET SOUTH & 130 FEET EAST FROM NE CORNER OF SECTION 9
- (point 3) SE 1/4 NE 1/4, Section 9, T 01 S, R 08 W, WM; 1850 FEET SOUTH & 650 FEET WEST FROM NE CORNER OF SECTION 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
