CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that

RALPH STAVER
DBA APLEGATE FARM
of 110 STRATFORD COURT DEL MAR, CA 92014
has a right to the use of the waters of APLEGATE LAKE RESERVOIR,
CONSTRUCTED UNDER PERMIT R-7810 TRIBUTARY OF APLEGATE RIVER
for the purpose of SUPPLEMENTAL IRRIGATION OF 34.8 ACRES.

The right to the use of these waters has been perfected
under Permit 47119. The date of priority is AUGUST 7, 1981 FOR
20.0 A.F. AND OCTOBER 22, 1982 FOR 14.0 A.F.
The right is limited to not more than 34.0 ACRE-FEET STORED WATER
ONLY
or its equivalent in case of rotation, measured at the point of
diversion from the source. The point of diversion is located as
follows:

SW 1/4 SW 1/4, Section 8, T 40 S, R 03 W, WM;
1040 FEET NORTH & 910 FEET EAST FROM SW CORNER SECTION 8 *

The right shall conform to such reasonable rotation system
as may be ordered by the proper state officer.

A description of the place of use under the right, and to
which such right is appurtenant, is as follows:

This right is limited to a diversion of 4.5 acre-feet per acre
for each acre irrigated during the irrigation season of each year,
provided further that the right allowed herein shall be limited to
any deficiency in the available supply of any prior right existing
for the same land and shall not exceed the limitation allowed
herein, and is subject to the terms and conditions of contract No.
2-07-10-W0466 , or a satisfactory replacement, between the Bureau
of Reclamation and the applicant, a copy of which is on file in
the records of the Water Resources Department.

* Applegate Dam is located in the S1/2 SE1/4, Section 25, T40S, R4W, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
