CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ARNOLD SANDWICK-TRUSTEE,
of ROUTE 3, BOX 262, BEND, OREGON , has a right to the use of the
waters of DESCHUTES RIVER, a tributary of COLUMBIA RIVER, for the
purpose of IRRIGATION OF 2.68 ACRES.

The right has been perfected under Permit 21807. The date of priority
is SEPTEMBER 30, 1952. The right is limited to not more than 0.067
CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured
at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 6, T 17 S, R 12 E, W.M.

The amount of water used for irrigation, together with the amount
secured under any other right existing for the the same lands, shall
be limited to ONE-FORTIETH of one cubic foot per second per acre, or
its equivalent for each acre irrigated and shall be further limited to
a diversion of not to exceed 4.0 acre-feet per acre for each acre
irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be
ordered by the proper state officer.

A description of the place of use under the right, and to which such
right is appurtenant, is as follows:

NW 1/4 NE 1/4 1.33 ACRES
SW 1/4 NE 1/4 1.35 ACRES
SECTION 31
TOWNSHIP 16 SOUTH, RANGE 12 EAST, W.M.

THE PLACE OF USE IS MORE EXPLICITLY DESCRIBED AS FOLLOWS:

LOTS 1, 2, 3, 4, 5; BLOCK 1. LOT 5; BLOCK 2. LOTS 7, 9, 10, 11, 12;
BLOCK 9. W1/2 LOTS 13, 14, 15, 16, 17, 18, 19, 20; BLOCK 18. LOTS 1
THROUGH 12; BLOCK 23. LOTS 7, 8, 9, 10; BLOCK 24. LOTS 2, 3; BLOCK 28.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 26128, Volume 18, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on MAY 26, 1988.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
