CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ROBERT F. RICKARD, of ROUTE 1, BOX 196, JEFFERSON, OREGON 97352, has a right to the use of the waters of FERN RIDGE RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of LONG TOM RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 70.3 ACRES.

The right has been perfected under Permit 41637. The date of priority is FEBRUARY 22, 1977. The right is limited to not more than 176 ACRE FEET or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 35, T 13 S, R 5 W, W.M.; 600 FEET SOUTH AND 1560 FEET WEST FROM THE E1/4 CORNER SECTION 35; RESERVOIR - NW 1/4 SW 1/4, SECTION 4, T 17 S, R 5 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to A DIVERSION OF NOT TO EXCEED 2 1/2 ACRE-FEET FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON AND IS SUBJECT TO THE TERMS AND CONDITIONS OF CONTRACT 7-07-10-W0015 BETWEEN THE BUREAU OF RECLAMATION AND THE APPLICANT, OR A SATISFACTORY REPLACEMENT, A COPY OF WHICH IS ON FILE IN THE RECORDS OF THE WATER RESOURCES DEPARTMENT.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NW 1/4 8.3 ACRES NE 1/4 SW 1/4 26.8 ACRES NE 1/4 SE 1/4 3.4 ACRES NW 1/4 SE 1/4 31.8 ACRES

SECTION 35

TOWNSHIP 13 SOUTH, RANGE 5 WEST, W.M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 48933, Volume 42, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on JULY 14, 1987.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
