CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that FRED SCHULZE,
of ROUTE 4, BOX 685, ROSEBURG, OREGON 97470, has a right to the use
of the waters of LOOKINGGLASS CREEK, a tributary of SOUTH UMPQUA
RIVER, for the purpose of IRRIGATION OF 32.5 ACRES.

The right has been perfected under Permit 19438. The date of priority
is MARCH 7, 1950. The right is limited to not more than 0.419 CUBIC
FOOT PER SECOND or its equivalent in case of rotation, measured at the
point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, NW 1/4 SE 1/4, AS PROJECTED WITHIN
HUNTLEY DLC 40, SECTION 2, T 28 S, R 7 W, W.M.

The amount of water used for irrigation, together with the amount
secured under any other right existing for the same lands, shall be
limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its
equivalent for each acre irrigated and shall be further limited to a
diversion of not to exceed 2.5 acre-feet per acre for each acre
irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be
ordered by the proper state officer.

A description of the place of use under the right, and to which such
right is appurtenant, is as follows:

SW 1/4 NE 1/4 22.7 ACRES
SE 1/4 NW 1/4 9.8 ACRES
ALL AS PROJECTED WITHIN HUNTLEY DLC 40
SECTION 2
TOWNSHIP 28 SOUTH, RANGE 7 WEST, W.M.

Land on which water is to be used is part of that described as follows: Beginning at the NE corner of the DLC of Joseph Huntley being claim #40 in T 28 S, R 7 W, W.M. Douglas County, Oregon; thence South on the East line of said claim 141 rods and 12 feet; thence West parallel with the North line of said claim to the West boundary line of said claim; thence North on the West boundary line of said claim to the North West corner of said, and thence East on the North line of said claim to the place of beginning, containing 182 114/160 acres more or less.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 33015, Volume 25, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on JULY 26, 1988, approving transfer application No. T-6020.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
