CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ED KROLOP, of ROUTE 1, BOX 64C, ARBUCKLE, CALIFORNIA 95912, has a right to the use of the waters of AGATE SLOUGH, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 9.0 ACRES.

The right has been perfected under Permit 10001. The date of priority is DECEMBER 29, 1930, FOR 0.075 CFS AND FEBRUARY 6, 1931, FOR 0.038 CFS. The right is limited to not more than 0.113 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL DIVERSION POINT: SE 1/4 SW 1/4, SECTION 15, T 36 S, R 2 W, W.M., 490 FEET NORTH AND 2210 FEET EAST FROM SW CORNER OF SECTION 15 or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 15, T 36 S, R 2 W, W.M.; PORTABLE PUMPING BETWEEN 950 FEET NORTH, 1300 FEET WEST, AND 850 FEET NORTH, 970 FEET WEST FROM SE CORNER SECTION 16; SW 1/4 SW 1/4, SECTION 15, T 36 S, R 2 W, W.M., 300 FEET NORTH AND 50 FEET EAST FROM SW CORNER SECTION 15.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SE 1/4 9.0 ACRES
SECTION 16
TOWNSHIP 36 SOUTH, RANGE 2 WEST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 3, 1977, and together with certificates 44951 AND 57703, supersedes certificate 9093, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
