## CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that J. L. HENDRICKSON, of 16405 AIRLIE ROAD, MONMOUTH, OREGON 97361, has a right to the use of the waters of LITTLE LUCKIAMUTE RIVER, a tributary of LUCKIAMUTE RIVER, for the purpose of IRRIGATING 38.5 ACRES.

The right has been perfected under Permit 19633. The date of priority is MARCH 7, 1950. The right is limited to not more than 0.48 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 2 (NW 1/4 SW 1/4) SECTION 31, T 8 S, R 5 W, W.M.; 2330 FEET NORTH AND 80 FEET EAST FROM SW CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
