CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ROBERT BELLAMY AND MICHAEL E. HUGIE, of 4700 ROGUE RIVER DRIVE, EAGLE POINT, OREGON 97524, has a right to the use of the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 88.0 ACRES.

The right has been perfected under Permit 3687. The date of priority is OCTOBER 29, 1917. The right is limited to not more than 1.1 CUBIC FEET PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, SW 1/4 SE 1/4, SECTION 16, TOWNSHIP 34 SOUTH, RANGE 1 WEST, W.M., 330 FEET NORTH & 1485 FEET WEST FROM SE CORNER SECTION 16, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 8 (NW 1/4 NE 1/4), LOT 7 (SW 1/4 NE 1/4), LOT 6 (SE 1/4 NW 1/4), LOT 3 (NE 1/4 SW 1/4), SECTION 28, LOT 2 (NE 1/4 SE 1/4) SECTION 29, T 34 S, R 1 W, W.M.; POD 1 - 200 FEET SOUTH & 3250 FEET EAST; POD 2 - 1410 FEET SOUTH & 3000 FEET EAST; POD 3 - PORTABLE PUMPING BETWEEN POINTS 2800 FEET SOUTH & 1350 FEET EAST - 2200 FEET SOUTH & 2640 FEET EAST; POD 4 - 3200 FEET SOUTH & 110 FEET WEST ALL FROM NW CORNER SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered OCTOBER 24, 1974, and together with certificate 46566, supersedes certificate 8589, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
