## CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that FRED SCHULZE, of ROUTE 4, BOX 685, ROSEBURG, OREGON 97470, has a right to the use of the waters of LOOKINGGLASS CREEK, a tributary of SOUTH UMPQUA RIVER, for the purpose of IRRIGATING 33.5 ACRES.

The right has been perfected under Permit 25902. The date of priority is DECEMBER 17, 1958. The right is limited to not more than 0.416 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4 AND NW 1/4 SE 1/4, BOTH AS PROJECTED WITHIN HUNTLEY DLC 40, SECTION 2, T 28 S, R 7 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of water in the South Umpqua River is 60.0 CFS or more at its mouth.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 0.4 ACRE
SE 1/4 NE 1/4 12.1 ACRES
NE 1/4 SW 1/4 2.7 ACRES
NE 1/4 SE 1/4 4.0 ACRES
NW 1/4 SE 1/4 14.3 ACRES
ALL AS PROJECTED WITHIN HUNTLEY DLC 40
SECTION 2

TOWNSHIP 28 SOUTH, RANGE 7 WEST, W.M.
