CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that CARROL D. PARKINSON, M. D., of ROUTE 1, BOX 146 F, JUNCTION CITY, OREGON 97448, has a right to the use of the waters of FERN RIDGE RESERVOIR, CONSTRUCTED UNDER PERMIT R-1625, a tributary of LONG TOM RIVER (WILLAMETTE RIVER), for the purpose of IRRIGATION 6.0 ACRES.

The right has been perfected under Permit 28797. The date of priority is NOVEMBER 13, 1962. The right is limited to not more than 15.64 ACRE FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN J. T. LASATER DLC 44, SECTION 8, T 17 S, R 5 W, W.M.; 210 FEET SOUTH AND 1430 FEET EAST FROM THE NW CORNER, LASATER DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THIS CERTIFICATE IS ISSUED SUBJECT TO THE TERMS OF CONTRACT NO. 14-06-100-2970., OR A SATISFACTORY REPLACEMENT BETWEEN THE UNITED STATES OF AMERICA THROUGH THE BUREAU OF RECLAMATION AND THE APPLICANT, A COPY OF WHICH IS ON FILE IN THE OFFICE OF THE WATER RESOURCES DIRECTOR.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 35761, Volume 27, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on AUGUST 18, 1988.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
