CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that WASHINGTON COUNTY FLAX GROWERS, of CORNELIUS, OREGON, has a right to the use of the waters of TUALATIN RIVER, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATION OF 39.5 ACRES.

The right has been perfected under Permit 18775. The date of priority is JUNE 2, 1949. The right is limited to not more than 0.494 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 46, SECTION 4, T 1 S, R 3 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 4.3 ACRES SE 1/4 NE 1/4 1.8 ACRES SE 1/4 NW 1/4 0.3 ACRE NE 1/4 SW 1/4 4.2 ACRES NE 1/4 SE 1/4 11.0 ACRES NW 1/4 SE 1/4 17.9 ACRES

ALL AS PROJECTED WITHIN EMERICK DLC 46 SECTION 4

TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 20104, Volume 14, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on AUGUST 18, 1988.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
