CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ARTHUR R./DEBRA THUNELL AND GEORGE LOGAN, of IZEE ROUTE, CANYON CITY, OREGON 97820, has a right to the use of the waters of SPRING 1, SPRING 2 AND CANYON CREEK, TRIBUTARIES OF JOHN DAY RIVER, for the purpose of DOMESTIC USE FOR TWO FAMILIES, IRRIGATION OF 1.0 ACRE AND SUPPLEMENTAL IRRIGATION OF 0.3 ACRE.

The right has been perfected under Permit 44818. The date of priority is JANUARY 18, 1980. The right is limited to not more than 0.05 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM SPRING 1 FOR DOMESTIC USE FOR TWO FAMILIES; 0.01 CFS FROM SPRING 2 FOR SUPPLEMENTAL IRRIGATION AND 0.03 CFS FROM CANYON CREEK FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW1/4 SW1/4, SW1/4 SW1/4, SECTION 24, T14S, R31E, WM; SPRING 1 - 1110 FEET SOUTH & 200 FEET EAST; SPRING 2 - 1550 FEET SOUTH & 120 FEET EAST; CANYON CREEK - 960 FEET SOUTH & 500 FEET EAST, ALL FROM W1/4 CORNER SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
