CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that WILLIAM AND FRANCINE DRABKIN, of ROUTE 1, BOX 294, SHERIDAN, OREGON 97378, has a right to the use of the waters of SOUTH YAMHILL RIVER, TRIBUTARY OF YAMHILL RIVER, for the purpose of IRRIGATING 26.7 ACRES.

The right has been perfected under Permit 41385. The date of priority is JANUARY 14, 1977 FOR 0.25 CFS AND FEBRUARY 28, 1977 FOR 0.08 CFS. The right is limited to not more than 0.33 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 3 (NE1/4 SW1/4), SECTION 33, T5S, R6W, WM; 175 FEET SOUTH & 100 FEET EAST FROM NE CORNER, NW1/4 SW1/4, SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 SW 1/4 3.6 ACRES
SW 1/4 SW 1/4 3.0 ACRES
BOTH AS PROJECTED WITHIN DLC 58

LOT 1 (SW 1/4 SW 1/4) 7.8 ACRES
SW 1/4 SW 1/4 4.6 ACRES
AS PROJECTED WITHIN DLC 39
SECTION 33
TOWNSHIP 5 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
