CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that GARY K. FAWVER FOR CAMP TILIKUM, INC., of ROUTE 3, BOX 462, NEWBERG, OREGON 97132, has a right to the use of the waters of AN UNNAMED STREAM AND E. R. BAKER RESERVOIR CONSTRUCTED UNDER PERMIT R-6237, A TRIBUTARY OF CHEHALEM CREEK, for the purpose of RECREATION AND IRRIGATION.

The right has been perfected under Permit 38823. The date of priority is NOVEMBER 29, 1973. The right is limited to not more than 0.31 CUBIC FOOT PER SECOND; BEING 0.01 CFS FOR IRRIGATION AND 0.3 CFS FOR RECREATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW1/4 NW1/4, AS PROJECTED WITHIN DLC 37, SECTION 5, T3S, R3W, WM; 120 FEET NORTH & 2400 FEET WEST FROM SE CORNER OF DLC 37.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
