CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that CYRIL J. AND ANITA FERSCHWEILER, of 5555 FERSCHWEILER LANE NE, GERVAIS, OREGON 97026, has a right to the use of TWO WELLS in the EAST CHAMPOEG CREEK BASIN for the purpose of IRRIGATION OF 37.1 ACRES.

The right has been perfected under Permit G-7672. The date of priority is APRIL 20, 1977. The right is limited to not more than 0.46 CUBIC FOOT PER SECOND FROM WELL #2 WITH ANY DEFICIENCY TO BE MADE UP FROM WELL #1 or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE1/4 SE1/4, AS PROJECTED WITHIN DLC 40, SECTION 17, NW1/4 NW1/4, AS PROJECTED WITHIN DLC 51, SECTION 21, T5S, R2W, WM; WELL #1 - 1520 FEET NORTH & 1330 FEET WEST; WELL 2 - 570 FEET SOUTH & 300 FEET WEST BOTH FROM SE CORNER MALVOIS DLC 40.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
