CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ROBERT L. AND ILENE WILSON, of 6277 WESTSIDE ROAD, CAVE JUNCTION, OREGON 97523, has a right to the use of the waters of WOODCOCK CREEK, AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6525, A TRIBUTARY OF WEST FORK ILLINOIS RIVER, for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 0.7 ACRE.

The right has been perfected under Permit 40912. The date of priority is JULY 30, 1976. The right is limited to not more than 0.025 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM WOODCOCK CREEK FOR IRRIGATION, 0.01 CFS FROM UNNAMED STREAM AND RESERVOIR FOR IRRIGATION, AND 0.005 CFS FROM UNNAMED STREAM AND RESERVOIR FOR DOMESTIC USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE1/4 SW1/4, SECTION 31, T39S, R8W, WM; WOODCOCK CREEK - 690 FEET SOUTH & 1070 FEET WEST; STREAM AND RESERVOIR - 60 FEET SOUTH & 1050 FEET WEST, BOTH FROM NE CORNER, SESW, SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

0.1 ACRE SE1/4 SW1/4 (WOODCOCK CREEK)
DOMESTIC & 0.6 ACRE SE1/4 SW1/4 (STREAM & RESERVOIR)
SECTION 31
TOWNSHIP 39 SOUTH, RANGE 8 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
