CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that JOHN P. AND JANE JONES, MARY NEWHOUSE AND LOWELL PRUTER, of 42345 HWY 22, HEBO, OREGON 97122, has a right to the use of the waters of BUCK CREEK AND A SPRING STREAM, TRIBUTARIES OF ALDER CREEK, for the purpose of IRRIGATING 2.8 ACRES AND DOMESTIC USE FOR TWO FAMILIES.

The right has been perfected under Permit 41668. The date of priority is APRIL 4, 1977. The right is limited to not more than 0.05 CUBIC FOOT PER SECOND; BEING 0.04 CFS FROM BUCK CREEK FOR IRRIGATION AND 0.01 CFS FROM THE SPRING STREAM FOR DOMESTIC USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE1/4 SW1/4, SE1/4 SW1/4, SECTION 9, T5S, R9W,
WM; SPRING STREAM - 1810 FEET NORTH & 2440 FEET EAST; BUCK CREEK-
1060 FEET NORTH & 1650 FEET EAST; 1070 FEET NORTH & 1810 FEET EAST;
930 FEET NORTH & 2260 FEET EAST, ALL FROM SW CORNER SECTION 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
