CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that LINO S. VIEIRA, of 3205 S. PACIFIC HWY, MEDFORD, OREGON 97501, has a right to the use of the waters of AN UNNAMED STREAM, VIEIRA RESERVOIR CONSTRUCTED UNDER PERMIT R-6512, A TRIBUTARY OF BEAR CREEK AND SOUTH FORK LITTLE BUTTE CREEK, TRIBUTARY OF LITTLE BUTTE CREEK, for the purpose of TEMPERATURE CONTROL OF 23.3 ACRES.

The right has been perfected under Permit 40834. The date of priority is JULY 1, 1976. The right is limited to not more than 0.35 CUBIC FOOT PER SECOND, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE UNNAMED STREAM AND RESERVOIR MAY BE MADE UP BY APPROPRIATION FROM SOUTH FORK LITTLE BUTTE CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE1/4 SE1/4, AS PROJECTED WITHIN DLC 40, SECTION 5, NW1/4 SW1/4, AS PROJECTED WITHIN DLC 40, SECTION 4, T38S, R1W, WM; NE1/4 SE1/4, SECTION 29, T36S, R2E, WM; STREAM - 1770 FEET NORTH & 780 FEET WEST FROM SE CORNER SECTION 5; RESERVOIR - 1725 FEET NORTH & 650 FEET EAST FROM SW CORNER SECTION 4; LITTLE BUTTE CREEK - 600 FEET SOUTH & 525 FEET WEST FROM E1/4 CORNER SECTION 29.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

0.5 ACRE SW1/4 NW1/4
9.0 ACRES NW1/4 SW1/4
BOTH AS PROJECTED WITHIN DLC 40
SECTION 4

0.1 ACRE SE1/4 NE1/4
13.7 ACRES NE1/4 SE1/4

SECTION 5
TOWNSHIP 38 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
