CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that EDITH LORRAINE YUNGEN, of ROUTE 1, BOX 153, DAYTON, OREGON 97114, has a right to the use of the waters of WILLAMETTE BASIN RESERVOIRS, CONSTRUCTED UNDER PERMITS R-1625 AND R-5363, TRIBUTARIES OF THE COLUMBIA RIVER, for the purpose of SUPPLEMENTAL IRRIGATING 67.9 ACRES.

The right has been perfected under Permit 41531. The date of priority is FEBRUARY 8, 1977. The right is limited to not more than 155.66 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 5, (NE1/4 SW1/4), SECTION 22, T5S, R3W, WM;  
360 FEET SOUTH & 850 FEET EAST FROM THE NE CORNER, J. PETERS DLC 58.

The right is limited to a diversion of 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract No. 7-07-10-W0009, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

4.8 ACRES LOT 2 (SE1/4 NE1/4)  
0.1 ACRE LOT 3 (SW1/4 NE1/4)  
5.3 ACRES LOT 4 (NW1/4 SE1/4)  
27.6 ACRES LOT 5 (NE1/4 SE1/4)  
SECTION 21

3.8 ACRES LOT 4 (SW1/4 NW1/4)  
1.6 ACRES LOT 5 (NE1/4 SW1/4)  
24.7 ACRES LOT 5 (NW1/4 SW1/4)  
SECTION 22

TOWNSHIP 5 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
