CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that AUGUST H. STEVENSON, of WEST HIGHWAY, JOHN DAY, OREGON 97845, has a right to the use of the waters of AN UNNAMED STREAM, A SPRING, AND THREE UNNAMED PONDS CONSTRUCTED UNDER PERMIT R-6306, A TRIBUTARY OF LUCE CREEK, for the purpose of PRIMARY IRRIGATION OF 2.6 ACRES, SUPPLEMENTAL IRRIGATION OF 2.2 ACRES, AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 39285. The date of priority is JULY 9, 1974 FOR SPRING & JULY 18, 1975 FOR STREAM & RESERVOIRS. The right is limited to not more than 0.125 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC AND 0.12 CFS FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located as follows:

NE1/4 SW1/4, NW1/4 SE1/4, SECTION 29, T13S, R31E,
W.M.; 1850 FEET NORTH & 30 FEET WEST, 1730 FEET NORTH & 90 FEET EAST,
BOTH FROM S1/4 CORNER SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
