CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that MOUNT HOOD IRRIGATION DISTRICT, C/O STEVE HATFIELD, of 6710 ALLEN ROAD, PARKDALE, OREGON 97041, has a right to the use of the waters of EAST FORK HOOD RIVER, A TRIBUTARY OF HOOD RIVER, for the purpose of IRRIGATION.

The right has been perfected under Permit 29613. The date of priority is MARCH 2, 1964. The right is limited to not more than 1.1 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW1/4 SW1/4, SECTION 4, T1S, R 10E, W.M.; 3750 FEET SOUTH & 430 FEET EAST FROM NW CORNER SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
