CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that WALTER R. MILLER, of P.O. BOX 12395, SALEM, OREGON 97309, has a right to the use of the waters of SUCKER SLOUGH AND SMALLMAN CREEK, TRIBUTARIES OF NORTH SANTIAM RIVER, for the purpose of IRRIGATING 321.2 ACRES.

The right has been perfected under Permit 37753. The date of priority is FEBRUARY 27, 1975. The right is limited to not more than 4.02 CUBIC FEET PER SECOND FROM THE SLOUGH WHEN AVAILABLE WITH A DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SLOUGH TO BE MADE UP BY APPROPRIATION FROM SMALLMAN CREEK PROVIDED THAT THE QUANTITY DIVERTED FROM THE CREEK SHALL NOT EXCEED 1.0 CFS or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

SUCKER SLOUGH: LOT 2 (SE1/4 SE1/4), SECTION 2, T10S, R2W, W.M.; 1120 FEET NORTH & 650 FEET WEST FROM SE CORNER, SECTION 2; SMALLMAN CREEK: NW1/4 SE1/4 AS PROJECTED WITHIN MCDONALD DLC 61, SECTION 35, T9S, R2W, WM; 50 FEET SOUTH & 100 FEET EAST FROM THE MOST WESTERLY NW CORNER MCDONALD DLC 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
