CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that JAMES H. AND DOROTHY FREEMAN, of 36723 FREEMAN ROAD, SCIO, OREGON 97374, has a right to the use of the waters of CRABTREE CREEK, A TRIBUTARY OF SOUTH SANTIAM RIVER, for the purpose of IRRIGATION OF 49.2 ACRES.

The right has been perfected under Permit 42844. The date of priority is JANUARY 9, 1978. The right is limited to not more than 0.62 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

DLC 45, SE1/4 SE1/4, SECTION 32, T10S, R1W, W.M.;  
950 FEET NORTH & 510 FEET WEST FROM SE CORNER SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

9.8 ACRES LOT 1 (NW1/4 SE1/4)  
4.7 ACRES LOT 1 (SW1/4 SE1/4)  
1.3 ACRES LOT 2 (NE1/4 SE1/4)  
0.2 ACRE LOT 2 (SE1/4 SE1/4)  
3.8 ACRES LOT 3 (SE1/4 SW1/4)  
17.6 ACRES SW1/4 SE1/4 AS PROJECTED WITHIN R. MOORE DLC 45  
4.4 ACRES SE1/4 SW1/4 AS PROJECTED WITHIN R. MOORE DLC 45  
7.4 ACRES SE1/4 SE1/4 AS PROJECTED WITHIN R. MOORE DLC 45  
SECTION 32  
TOWNSHIP 10 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
