CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, that ROBERT AND CAROL FOLEY, of 182 OLD CABIN ROAD, GLIDE, OREGON 97443, has a right to the use of the waters of LITTLE RIVER AND AN UNNAMED STREAM, A TRIBUTARY OF NORTH UMPQUA RIVER, for the purpose of IRRIGATION OF 3.4 ACRES AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 47889. The date of priority is MAY 12, 1983, FOR UNNAMED STREAM AND SEPTEMBER 27, 1983, FOR LITTLE RIVER. The right is limited to not more than 0.045 CUBIC FOOT PER SECOND; BEING 0.04 CFS FROM LITTLE RIVER FOR IRRIGATION AND 0.005 CFS FROM UNNAMED STREAM WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE UNNAMED STREAM TO BE MADE UP BY APPROPRIATION FROM LITTLE RIVER FOR DOMESTIC USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE1/4 NW1/4, SE1/4 NW1/4, SECTION 34, T26S, R3W, W.M.; LITTLE RIVER - 1120 FEET SOUTH & 1950 FEET EAST, UNNAMED STREAM - 2550 FEET SOUTH & 2025 FEET EAST, BOTH FROM NW CORNER SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

1.8 ACRES SE1/4 NW1/4
1.6 ACRES NE1/4 SW1/4
DOMESTIC & NW1/4 SE1/4
SECTION 34
TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
