CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELLS 2, 3, AND 4 IN THE WILLAMETTE RIVER BASIN for the purpose of PRIMARY IRRIGATION OF 8.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 101.8 ACRES.

The right has been perfected under Permit G-7366. The date of priority is FEBRUARY 14, 1977. The right is limited to not more than 1.37 CUBIC FEET SECOND; BEING 0.1 CFS FROM WELL 2 FOR IRRIGATION WITH ANY DEFICIENCY FROM WELL 2 TO BE MADE UP BY APPROPRIATION FROM WELLS 3 AND 4; 1.27 CFS FROM WELLS 3 AND 4 FOR SUPPLEMENTAL IRRIGATION BEING 0.73 CFS FROM WELL 3 AND 0.54 CFS FROM WELL 4 or its equivalent in case of rotation, measured at the well. The wells are located as follows:

NW 1/4 NE 1/4, SECTION 5, T 16 S, R 4 W, W.M.;  
WELL 2 - 970 FEET SOUTH & 1700 FEET WEST; WELL 3 - 1040 FEET SOUTH & 1320 FEET WEST; WELL 4 - 1020 FEET SOUTH & 1880 FEET WEST ALL FROM NE CORNER SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SECTION 5

TOWNSHIP 16 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
