confirms the right to use the waters of WILLAMETTE RIVER, TRIBUTARY OF COLUMBIA RIVER, for the purpose of IRRIGATING 87.4 ACRES.

The right has been perfected under Permit 47006. The date of priority is DECEMBER 6, 1978. The right is limited to not more than 1.09 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 7, T 17 S, R 3 W, W.M.;  
2640 FEET NORTH & 2760 FEET WEST FROM SE CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
