CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NORTH UMPQUA RIVER AND A SPRING, a tributary of UMPQUA RIVER, for the purpose of IRRIGATION OF 8.8 ACRES AND STOCK USE.

The right has been perfected under Permit 42388. The date of priority is AUGUST 1, 1977. The right is limited to not more than 0.115 CUBIC FOOT PER SECOND; BEING 0.11 CFS FROM NORTH UMPQUA RIVER FOR IRRIGATION AND 0.005 CFS FROM THE SPRING FOR STOCK WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SPRING FOR STOCK TO BE MADE UP BY DIVERSION FROM NORTH UMPQUA RIVER or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, NE 1/4 SW 1/4, BOTH AS PROJECTED WITHIN DLC 43, SECTION 22, T 26 S, R 6 W, W.M.; RIVER - 950 FEET NORTH & 450 FEET WEST; SPRING - 1640 FEET NORTH & 3520 FEET WEST, BOTH FROM SE CORNER SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 2.0 ACRES & STOCK
NW 1/4 SW 1/4 0.1 ACRE
SW 1/4 SW 1/4 0.8 ACRE
SE 1/4 SW 1/4 5.9 ACRES & STOCK
ALL AS PROJECTED WITHIN H. EVANS DLC 43
SECTION 22
TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
