CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of MAPLE SPRINGS GULCH, AN UNNAMED STREAM & HOLZHAUSER RESERVOIR CONSTRUCTED UNDER PERMIT R-7701, a tributary of WILLIAMS CREEK, for the purpose of IRRIGATING 1.3 ACRES AND MAINTENANCE OF THE RESERVOIR FOR WILDLIFE ATTRACTION.

The right has been perfected under Permit 43463. The date of priority is FEBRUARY 8, 1978. The right is limited to not more than 0.03 CUBIC FOOT PER SECOND; BEING 0.02 CFS FOR IRRIGATION AND 0.01 CFS FOR THE MAINTENANCE OF THE RESERVOIR FOR WILDLIFE ATTRACTION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 2 (NW 1/4 NE 1/4), SECTION 26, T 38 S, R 5 W, W.M.;
740 FEET SOUTH & 1330 FEET WEST FROM NE CORNER SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4 WILDLIFE
LOT 2 (NW 1/4 NE 1/4) 0.2 ACRE & WILDLIFE
NW 1/4 NE 1/4 1.1 ACRES & WILDLIFE
AS PROJECTED WITHIN DLC 38
SECTION 26
TOWNSHIP 38 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
