CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of COOPER CREEK AND STANLEY RESERVOIR CONSTRUCTED UNDER PERMIT R-8370, a tributary of SUTHERLIN CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 11.1 ACRES.

The right has been perfected under Permit 46508. The date of priority is JULY 14, 1981. The right is limited to not more than 0.5 ACRE-FOOT STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 2 (SW 1/4 NE 1/4), SECTION 20, T 25 S, R 5 W, W.M.;
10 FEET SOUTH & 1150 FEET EAST FROM SW CORNER OF DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 3.8 ACRES
AS PROJECTED WITHIN DLC 51
LOT 2 (SW 1/4 NE 1/4) 2.0 ACRES
SE 1/4 NW 1/4 1.7 ACRES
AS PROJECTED WITHIN DLC 51
SE 1/4 NW 1/4 0.8 ACRE
NE 1/4 SW 1/4 0.3 ACRE
BOTH AS PROJECTED WITHIN DLC 39
LOT 3 (NW 1/4 SE 1/4) 2.5 ACRES
SECTION 20
TOWNSHIP 25 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
