## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEBHARD ORCHARDS BY EDWIN W. &/OR FRNKLIN H. GEBHARD 446 BEEBE ROAD CENTRAL POINT, OREGON 97502

confirms the right to use the waters of AN UNNAMED SWALE AND GEBHARD RESERVOIR 2 CONSTRUCTED UNDER PERMIT R-10022. ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE UNNAMED SWALE MAY BE MADE UP FROM THE SOUTH FORK LITTLE BUTTE CREEK WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SOUTH FORK LITTLE BUTTE CREEK TO BE MADE UP FROM NORTH FORK LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of TEMPERATURE CONTROL OF 32.5 ACRES.

The right has been perfected under Permit 48870. The date of priority is JANUARY 27, 1984. The right is limited to not more than 4.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 2 (SW 1/4 NW 1/4), SECTION 1, T 37 S, R 2 W, W.M., NE 1/4 SE 1/4, SECTION 29, SE 1/4 NE 1/4, SECTION 20, T 36 S, R 2 E, W.M.; SWALE & RESERVOIR - 1900 FEET SOUTH & 1130 FEET EAST FROM NW CORNER, SECTION 1; SOUTH FORK LITTLE BUTTE CREEK - 600 FEET SOUTH & 525 FEET WEST FROM E1/4 CORNER SECTION 29; NORTH FORK LITTLE BUTTE CREEK - 60 FEET NORTH & 639 FEET WEST FROM E1/4 CORNER SECTION 20.

The right shall conform to such reasonable rotation, system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 2 (SW 1/4 NW 1/4) 13.8 ACRES
SE 1/4 NW 1/4 3.0 ACRES
LOT 4 (NE 1/4 SW 1/4) 15.7 ACRES
SECTION 1
TOWNSHIP 37 SOUTH, RANGE 2 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
