CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRANTS PASS, OREGON 97526

confirms the right to use the waters of TWO SPRINGS AND WEST FORK FALL CREEK, a tributary of GRAVE CREEK, for the purpose of DOMESTIC USE FOR ONE FAMILY, IRRIGATION OF 19.1 ACRES, AND SUPPLEMENTAL IRRIGATION OF 3.2 ACRES.

The right has been perfected under Permit 34613. The date of priority is AUGUST 18, 1969. The right is limited to not more than 0.285 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC USE FROM SPRING A; 0.10 CFS FOR IRRIGATION FROM SPRING B; AND 0.18 CFS FOR IRRIGATION FROM CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 26; NW 1/4 NE 1/4, SECTION 35, T 33 S, R 7 W, W.M.; SPRING A - 530 FEET NORTH & 760 FEET WEST; SPRING B - 390 FEET NORTH & 1140 FEET WEST; CREEK - 790 FEET SOUTH & 1440 FEET WEST ALL FROM SE CORNER SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
