CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LICK CREEK, WEST FORK SHINGLE CREEK AND STAR RESERVOIR CONSTRUCTED UNDER PERMIT R-2999, tributaries of LITTLE BUTTE CREEK, for the purpose of IRRIGATING 66.3 ACRES.

The right has been perfected under Permit 28160. The date of priority is JULY 16, 1962. The right is limited to not more than 0.82 CUBIC FOOT PER SECOND, BEING 0.62 CFS FROM LICK CREEK AND 0.20 CFS FROM WEST FORK SHINGLE CREEK AND STAR RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion from the source. The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 25, T 35 S, R 1 E, W.M.; NW 1/4 SE 1/4, SECTION 29, NE 1/4 NE 1/4, SECTION 32, T 35 S, R 2 E, W.M.; LICK CREEK - 800 FEET NORTH AND 4400 FEET EAST FROM THE SW CORNER SECTION 25, T 35 S, R 1 E, W.M. AND 2450 FEET NORTH AND 1250 FEET EAST FROM THE S1/4 CORNER, SECTION 29; WEST FORK SHINGLE CREEK - 1150 FEET SOUTH AND 2250 FEET EAST FROM THE N1/4 CORNER SECTION 32, T 35 S, R 2 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT TO USE OF WATER FROM DIRECT FLOW SHALL BE LIMITED TO THE PERIOD WHEN LITTLE BUTTE CREEK IS MORE THAN 31 CFS AT ITS MOUTH AND THE FLOW OF THE ROGUE RIVER AT RAYGOLD IS MORE THAN 1000 CFS AND MORE THAN 1000 CFS IMMEDIATELY ABOVE SAVAGE RAPIDS DAM AND MORE THAN 735 CFS AT ITS MOUTH.

The right shall conform to such reasonable rotation, system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4	10.2 ACRES
NE 1/4 NW 1/4	9.4 ACRES
NW 1/4 NW 1/4	17.6 ACRES
SW 1/4 NW 1/4	11.6 ACRES
SE 1/4 NW 1/4	17.5 ACRES

SECTION 36

TOWNSHIP 35 SOUTH, RANGE 1 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
