CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HENRY L. LAUTHENBACH

confirms the right to use the waters of WASTE LAGOON CONSTRUCTED UNDER PERMIT R-6570, a tributary of SPRING VALLEY CREEK, for the purpose of PRIMARY IRRIGATION OF 62.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 54.7 ACRES.

The right has been perfected under Permit 41508. The date of priority is DECEMBER 30, 1976. The right is limited to not more than 18.8 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 49, SECTION 19, T 6 S, R 3 W, W.M.; 310 FEET SOUTH AND 620 FEET EAST FROM NE CORNER OF PHILLIPS DLC 50.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, and shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
