## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON DEPARTMENT OF FISH & WILDLIFE 506 SW MILL STREET PORTLAND, OREGON 97207

confirms the right to use the waters of FERN RIDGE RESERVOIR CONSTRUCTED UNDER PERMIT R-1625 AND CLEARY CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-8548, a tributary of LONG TOM RIVER, for the purpose of IRRIGATING 314.0 ACRES.

The right has been perfected under Permit 47242 AS AMENDED AUGUST 16, 1988, BY SPECIAL ORDER RECORDED IN VOLUME 42 AT PAGES 341 AND 342. The date of priority is APRIL 30, 1979, FOR 30.0 ACRE FEET FROM CLEARY RESERVOIR AND NOVEMBER 20, 1981, FOR 559 ACRE FEET FROM FERN RIDGE RESERVOIR. The right is limited to not more than 589.0 ACRE FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

CLEARY RESERVOIR - SE 1/4 NE 1/4, SECTION 35, T 17 S, R 5 W, W.M.; FERN RIDGE RESERVOIR - NE 1/4 SW 1/4, SECTION 4, T 17 S, R 5 W, W.M.; PUMPING POINTS - NE 1/4 SE 1/4, SECTION 34, SE 1/4 NW 1/4 SECTION 35, T 17 S, R 5 W, W.M.; 2570 FEET NORTH & 1200 FEET WEST; 3210 FEET NORTH & 1640 FEET EAST BOTH FROM SW CORNER SECTION 35.

The right shall conform to such reasonable rotation, system as may be ordered by the proper state officer.
