CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RUTH BETTY LANGDON BERHEIM
ROUTE 3, BOX 488
AURORA, OREGON 97002

confirms the right to use the waters of A WELL in the WILLAMETTE RIVER BASIN for the purpose of IRRIGATION 63.7 ACRES.

The right has been perfected under Permit G-4034. The date of priority is MARCH 18, 1968. The right is limited to not more than 0.575 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 35, T 3 S, R 1 W, W.M.; 1320 FEET NORTH & 680 FEET WEST FROM THE E1/4 CORNER SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4	17.1 ACRES	SE 1/4 NE 1/4	35.4 ACRES
NW 1/4 NE 1/4	4.5 ACRES	NE 1/4 SE 1/4	0.5 ACRE
SW 1/4 NE 1/4	5.7 ACRES	NW 1/4 SE 1/4	0.5 ACRE

SECTION 35
TOWNSHIP 3 SOUTH, RANGE 1 WEST, W.M.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 50462, Volume 44, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on OCTOBER 17, 1988.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
