CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. L. HENDRICKSON  
16405 AIRLIE ROAD  
MONMOUTH, OREGON 97361

confirms the right to use the waters of LITTLE LUCKIAMUTE RIVER, a tributary of LUCKIAMUTE RIVER, for the purpose of IRRIGATION OF 38.9 ACRES.

The right has been perfected under Permit 21626. The date of priority is JULY 21, 1952. The right is limited to not more than 0.49 cubic foot per second, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; NE 1/4 SW 1/4, SECTION 6, T 9 S, R 5 W, W.M. or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 2 (NW 1/4 SW 1/4), SECTION 31, T 8 S, R 5 W, W.M.  
AND LOT 1 (NE 1/4 NE 1/4), SECTION 36, T 8 S, R 6 W, W.M.; 2330 FEET NORTH & 80 FEET EAST FROM SW CORNER SECTION 31, 1280 FEET SOUTH & 630 FEET WEST FROM NE CORNER SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 29, 1977, and supersedes certificate 24210, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
