CERTIFICATE OF WATER RIGHT

This is to Certify, That GEO. W. ELLIOTT

of Baker, State of Oregon has a right to the use of

the waters of Pine Creek for Mining in Tract #1 and for Irrigation in Tract #2; Reed Creek for Tract #3 and Indian Creek for Tract #4, tributaries of Burnt River; for the purpose of Irrigation and Mining

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 134; that the priority of the right thereby confirmed dates from 1868 for Tract #1; 1882 for Tracts #2, #3, and #4;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Two and five tenths cubic feet per second for mining purposes and three acre feet per acre during any irrigation season (with the further limitations contained in Paragraph 64 of said decree);

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1. (For Mining.)

Mines located in Sections Fifteen (15), Twenty-two (22), Twenty-six (26), and Twenty-seven (27), Township Twelve (12) South, Range Thirty-nine (39) East of the Willamette Meridian.

Tract #2. (For Irrigation.)

Eight (8) acres in the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$), Seven (7) acres in the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-seven (27), Township Twelve (12) South, Range Thirty-nine (39) East of the Willamette Meridian, being a total of 15 acres.

Tract #3. (For Irrigation.)

Nine (9) acres in the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Eleven (11) acres in the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-seven (27), Township Twelve (12) South, Range Thirty-nine (39) East of the Willamette Meridian, being a total of 20 acres.

Tract #4. (For Irrigation.)

Three (3) acres in the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) Five (5) acres in the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Twelve (12) acres in the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Twenty-six (26), Township Twelve (12) South, Range Thirty-nine (39) East of the Willamette Meridian, being a total of 20 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
